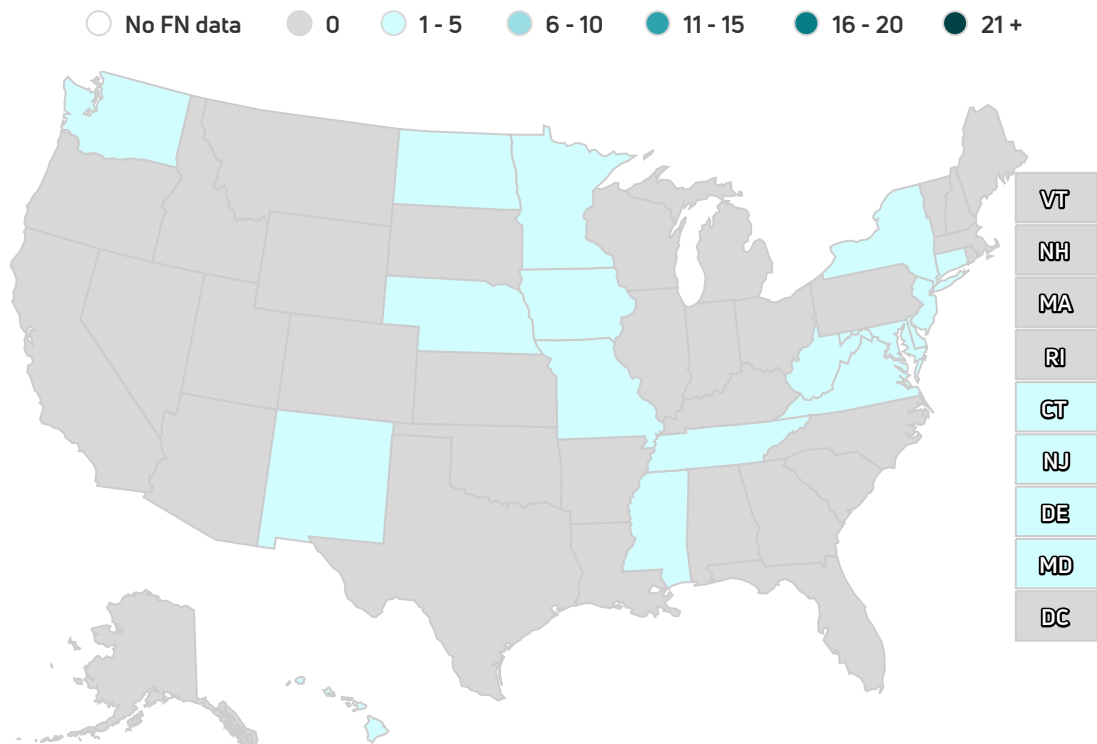

This information about your breast density is being provided to you to raise your awareness. It is important to continue routine screening mammograms and use this information to speak to your health care provider about your own risks for breast cancer. At that time, ask your health care provider if more screening tests might be useful based on your risk. A report of your mammogram results was sent to your health care provider."
