Dear Senators Sanders and Cassidy,

ACR believes Dr. Bertagnolli is an ideal candidate for this nomination, and we urge her swift confirmation.

As Director of the National Cancer Institute (NCI), Dr. Bertagnolli has both the experience of running one of the largest government agencies in the country as well as the proven ability to navigate the challenges of the federal legislative and regulatory processes. Dr. Bertagnolli has worked with various non-profits and associations, as well as government entities and private industry, and she is well equipped to engage with the numerous audiences that interact with the Office of the NIH Director.
